
Sir, I am proud of our institution for inculcating ethical and moral values among students along with elevated standards of learning. However, despite the ethical, humane and moral standards of our institution, I noticed one of our colleagues intentionally violating the code of our institution. I, in the capacity of Placements Officer and Training Incharge came across a grave incident during my visit to one such mentoring session taken by Mr. V. V. Santosh Kumar.

On 6th March'24, at around 5:30 PM, I noticed that a few female students were engaged in some training task in EB-101A. Upon observing, I found Mr. V V Santosh Kumar sitting very close with a girl in an inappropriate way and was playing with her Identity Card which was at her belly. I intervened in the session; however, Mr. Santosh orchestrated the situation spontaneously so that everything would appear normal. Later that day, I spoke to the concerned students and learnt that his behaviour is physically very inappropriate towards our female students.

I am shaken by the sight of such a scene in our institution and want this to be brought to light. It's a humble request sir to please take necessary action in this regard on behalf of all the female students of our institution.

The committee has discussed with Head- IT and the tech support team extensively. The committee made an inquiry about the internet speed presently and get to know that MITS has BSNL connectivity with 1Gbps dedicated leased line (1:1) and also Airtel Connectivity 1Gbps (OFC) has been procured. Due to which there are interruptions when many users go into online, during the break times and examination time. Hence, to regularize the speed the committee had recommended for broadband connectivity of Airtel as the users opined the better performance of Airtel Broadband.

Later management provided Airtel Broadband connectivity with 1400 Mbps (10 connections) in 2024 academic year.

The committee has discussed with Senior Administrative Officer and HR department about the 2nd complaint. The request for Inclusion of Delivery expenses (for faculty) in STAR Medical Insurance has been thoroughly discussed with the heads of the above mentioned departments. The committee recommended to approve the same for the welfare of the faculty. Hence, the approval of availing the Delivery expenses have been included.
